As you know the Fire Security/Fincantieri Marinette Marine (FMM)/Hepburn team had a very successful Demonstration Day at FMM last week. We had 22 participants at the Demonstration. Additionally, the Final Report for this project is due this Friday, April 29. After discussing with multiple folks, we would like to request a No Cost Extension for the Final Report. This additional time would allow time for FMM Security to provide clearance for pictures from the Demonstration to be included in the Final Report, allow time to develop better ROI information, allow time for a PTR review prior to submittal and help offset a resource issue.
